- Call meeting to order Call called the meeting to order at 6:04
- Roll Call Call, Taylor, Mardi, Stephanie, Mike, Meagan, Kelly, Tammy, Kyler, Jackie

- Approval of Meeting Minutes Mardi Motioned to approve the minutes, Kelly 2nd, motion passed
- Treasurer's Report We have been ordering some awards and put deposits on some of our entertainment items. Sponsorships have been coming in. Stephanie Motioned to approve the treasures report, Mardi 2nd, motion passed
- Visitor Comments: (10 minutes maximum/visitor/group)
- Shania with the cattle women's association- They would like to do the BBQ contest; they want to do it Friday night 8/12 possibly at 5:30. They are going to try to do pre-sales this year.
- Donald with the county commissioners is here. they are concerned about the contract with OA regarding them requesting their payment in full no matter what even if its due to weather or them just canceling it. Kelly talked that maybe we have them change the wording that we would only be paying out to them in full if there is a catastrophic event. Have them change the wording "promotor" to "Moffat County Fair Board". Kelly called Tyler with OA during our meeting to discuss the issues. Tyler confirmed that the "promotor" in the contract is Moffat County Fair Board. Tyler said he has never had to cancel a show before. If in the event of bad weather, he would try to wait it out, in the event he could not wait out the bad weather he would try to reschedule with us however he said he would like us to pay a little more for the additional use of gas. Tyler recommended we get event/weather insurance in the case of cancelation/rescheduling. After the phone call with Tyler the board has decided to move forward with signing the contract after we convert it to our County Contract with the wording change from " Promotor" to Moffat County Fair" Kyler Motioned for this approval, Meagan 2nd, Motion passed
- Old Business:
 - Improvement Items- The county commissioners are paying for the electrical so now we need to spend some money before June 30th. Bill Sixkiller would like some more panels and some venting in the picnic area.
 - Time Clock-\$2,500 with shipping (Meagan needs to know what brand our "I" (farm tech is our current one) is, they can make the new system work with our old one. 45"long 12" tall, they don't recommend you leave them outside
 - 36" porta cool is about \$3,000, 34" \$2,300.00,48" is \$3,895.
 - Door and lock for the office upstairs, Call will go to Samuelson's tomorrow to purchase this.
 - Extra shelving for our current shed. We will buy the supplies and Murr can have the ag kids make the shelves for next year, we will buy the materials now though.
 - \$6,000 for the shed and the quilt rack
 - \$1,500 for the door and the window
 - \$8,000 for 2-48" portable swamp coolers
 - \$3,000 for the time clock
 - \$1,000 for the boxes for the tents
 - Kyler motioned to pay \$19,500 on the above listed items, Kelly 2nd, motion passed.

- Photos (Shannon Lukens) Asked that we pay her for the photos she has taken at the fair for us to be able to use them. Board agreed that we will pass on the use of her photos.
- Rabbit Classes etc. "what is a junior rabbit?" rabbit leader found some resources with the definition and clarification on what a junior rabbit is. Tammy motioned that we adjust the fair book to reflect the advice given by the rabbit leader, Kyler second, motion passed.
- Ambulance Do we ask TMH to cover events or ask EMS reserves to cover the events Kelly and Kyler will look into this.
